

## LEGISLATIVE PROCEEDINGS.

SAN JOSE, April 21st.

MESSRS EDITORS.—In the Senate, on Friday, the bill concerning limitations was read the third time and passed; also the bill for the protection and government of Indians: also a bill to pre-

~~scribe the duties of magistrates, also the bill con-~~  
cerning licenses. The joint resolutions from the Assembly concerning slavery in the states were taken up, and after having been amended, were, on motion of Mr. Broderick, indefinitely postponed. The following bills were read the third time and passed. A bill concerning the county of Marin and other organized counties of the State: a bill in relation to set-off; a bill for the relief of persons imprisoned in civil cases.

In the Assembly; the following bills were read the third time and passed: Bill for the relief of persons imprisoned in civil cases: a bill concerning jurisdiction in certain counties of this State: a bill concerning set-off. The bill to regulate proceeding against debtors by attachment, was taken up, and referred to the judiciary committee. The bill relating to the partition of lands owned by several persons, was indefinitely postponed. The bill to abolish laws now in force in the state, except such as have been or may hereafter be passed by the present legislature, was under consideration, and was referred to the judiciary committee. The joint resolution in regard to slavery in the states and territories, was read a third time and passed:

In the Senate, on Saturday, the bill to regulate proceedings against debtors by attachment, was read the third time and passed. The bill to provide for the distribution of the laws, journals, court reports, &c., was read a third time and passed. The bill to suppress gaming, was read first and second times, and laid on the table for the present. The bill to change or abolish certain provisions of the common law was in de-

In the Assembly, the Speaker laid before the house, a communication from the Hon. Henry A. Tefft, tendering his resignation as a member of the Assembly, from the District of San Luis Obispo. The bill to regulate proceedings against debtors by attachment was amended, read the third time and passed; also, the bill to abolish all laws now in force in the State, except such ~~as have been or may hereafter be passed by the~~ present Legislature; also, the bill to suppress gaming. Mr. Crittenden from the Judiciary committee reported a substitute for the bill to change or abolish certain provisions of the Common Law, which substitute was adopted, and the bill was read the third time and passed: Mr. Clarke presented a petition from sundry Physicians of San Francisco, remonstrating against the passage of an Act to regulate the Practice of Medicine and Surgery. The bill to provide for the distribution of the laws, journals, &c., was read the first and second times and referred to the Committee on printing. JERSEY.
