INDIAN TOUT.—The Colusa Sun contains an account of an Indian fight, near Little Stony crock, between a party of whites and a band of Pitt River Indians, under the leadership of the notorious Hat Greek Lize, well-known in the Pitt River country as a desperate Indian woman of large stature, and celebrated for various barbarities. Two of the whites, S. W. Shannon and S.R. Ford were killed, and about fifteen of the Indians, among whom was Lize and two other squaws. This band had been guilty of robbing houses killing stock, and the murder Mr. H. Was son and an Indian boy who was herding sheep.
