Report of the Grand Jury of Klamath

To the Honorable, the Court of Sessions of Klamath County.

The Grand Jury empanneled by this Court would respectfully beg leave to report, That in addition to the Special Report, made by this Body, by which J. B. Cecil, Sheriff of this County, is fully exonerated from all charges of dishonesty; that we have carefully examined the accounts of W.T. Stevens Auditor, and J. T. Garey, Treasurer of this County; that we find their Books kept with propriety and correctness, and their accounts with the County and State evenly and squarely balanced, and the money (to balance) in the Treasury. That we have examined into the condition, purchase and erection of the various public-buildings belonging to the county; that the same are highly to its credit, and that the interest of the county has been preperly consulted by their purchase and erection.

That we have found a Bill of Indictment against an Indian now in custody, for murder of a white man, and in connection with this subject would earnestly call the attention.

tion of the Superintendent of Indian Athurs T to the condition of this county as regards our improtected state. We would represent to him that from the mouth of Urisity River er to the county line on the Klamath River, there—is—a-section of country as flickly settled by Indians, if not more so, than any other portion of the county. That this portion is purely a mining district, open to the nelarious depredations of the Indians; that from information we have received we are fully satisfied that more than eight murders of white men have been committed in that section, although we are unable to flisten, the guilt on the particular parties. In these cases—and we believe many more exist—it is not citizens who are known to us, who are killed, but travelers whose disappearance willlikely cause no inquiry, are the ones selected; And we would respectfully ask of the said Superintendent that he cause a depot of military forces to be stationed at, or near the mouth of Salmon River, believing that only by such means can scentity be afforded to those who travel through that section of nur county. And we would urge upon the penple of this county to co operate with us to this end. - We further recommend the pulication of this Report, in the Hinmboldt Jimes and Northern Colifornian; and copies sent to said Superintendent.
