

**INTERESTING FROM PITT RIVER.**—On Sunday, June 21st, S. H. Jenner, arrived at Yreka from Red Bluffs, by the Pitt River road. The following summary of news is made up by the Yreka Union:

S. H. Jenner came up in company with four loaded teams, and a peddler's wagon; he reports the road in good condition except one difficult hill. Near the junction of Fall River with Pitt River, he saw the body of a white man hanging to a tree; the body was considerably mutilated and the stench was so offensive that he could not go near it. The ferry boat at Lockhart's is completed and there is no difficulty in crossing the river. Quite a village is growing up at the crossing. There are two rum mills, and a considerable number of tents and canvas houses. The soldiers stationed at Pitt River have frequent skirmishes with the Indians; they go out in bodies of four or five men; if a larger body goes out it is very difficult for them to get upon the Indians without being discovered. Lieut. Crooks, who was wounded in the the thigh some time ago with an arrow, is much better, and is able to walk about. The head of the arrow was in his thigh some six days, and from the nature of its construction had to be taken out on the other side from where it entered. Dr. Kinney, of Fort Jones, was sent for and went down to extract it. Jenner met a large quantity of stock on the road, bound for the lower country. A child was smothered in a wagon belonging to a body of Oregon immigrants three or four days this side of Red Bluffs; the unhappy parents had the body preserved in spirits for the purpose of taking it to Red Bluffs for interment. Our informant states that the Indians are numerous in Pitt River Valley, but if one man meets a body of twenty or twenty-five of them and shows any kind of fire-arms they will run. He also met T. A. Bantz, of this place, who was on his way down to the Bluffs, on his way to the Atlantic States.
