

INDIAN WAR CLAIM NOTICE.—Gen. Kibbe, President of the Board of Examiners, sends us the following notice, which we publish for the benefit of the parties concerned. It seems that the report about the loss of the original papers proves correct.

**Notice—To all Whom it May Concern.**

Persons having claims against the State of California for services rendered, supplies furnished, or property destroyed in the Indian War, in the counties of Humboldt and Klamath, in the year 1855, also for services rendered and supplies furnished in Klamath county for the year 1852, are hereby notified that the Board of Examiners are now in session, in the city of Sacramento, and ready to act upon such claims as may come properly verified.

The papers should be verified by oath, or by certificate of commissioned officers of the expedition for which the claims were incurred.—

The original papers acted upon by Commissioners McDonald and Jones having been lost, others will necessarily be required to be filed for the action of the Board of Examiners. As the Board of Examiners are required to report to the Governor on, or before, the 25th of December next, it is desirable that the papers should be filed at an early day.
