Were killed by Indians a few days since, at the Spruce Grove Mail Station in the southern part of the county. The horses were owned by the contractors, and were in use for the transportation of the mail.

Work, Captain; Green Wilkinson, First Lieutenant; James Brown and John P. -Warren Second Lieutenauts The duties of Quartor-Master and Commissary are performed by W. C. Martin, of the Brigade Staff. We have no copy of the muster-roll to enable us to give the names of the non-commissioned officers and privates. The company has been divided into three detachments and apportioned to different sections of the county for service. Our readers shall be informed of the movements of the several detachinents from time to time.

The company have adopted the name of the Humboldt Home Guards.
