

Indian Reservations.

The time has been when a deep interest was felt in the rude children of the forest, and the circumstances connected with their history, their situation and their fate: furnished the theme for conversation during many a long evening. But that spirit, which mocked at the restraints of civilized life, which loved the pathless wilderness, the unbroken solitude, and the pure blue sky, and which listened with reverence to the voice of the "Great Spirit," speaking in every passing change, has been completely broken; and the once glad possessors of these beautiful valleys and hill sides, are now wasting away, affording at the present only pitiful objects of curiosity and compassion, sunken and degraded by vices, and seemingly destitute of every thing, save an outward form, upon which they may ground their claim to a membership of the human family.

Under these circumstances, not only for the sake of humanity, but as a matter of justice and right, the Federal Government adopted the policy of locating them upon tracts of the public land, where they might receive such care as their necessities strongly demand.—Accordingly, the reservations were set off, and the work of removal actively commenced. Every thing was there provided for their comfort and welfare, and had it not been for the foolish opposition of a few white men, the purpose of the Government would ere this have been fully carried out. In consequence of this opposition many yet remain, and disease, want, discontent, and a multitude of evils are rapidly destroying them. Their thievish disposition renders them a serious trouble to the miners and ranch men in various portions of the State, and a strong desire is expressed by the majority of the people that the remnant of the tribes may be removed.

For this purpose Mr. Storms, sub-agent, is now in this vicinity, and with a little co-operation on the part of the people, the desired object may be effected.—The Indians themselves know, from the representations of their brethren at the Reservation, that once there, they will be well cared for, and on their part no particular reluctance is manifested.
