### Special Correspondence.

SAN FRANCISCO, Jan. 5, 1852.

Yesterday was a delightful day; the sky was slightly overcast, but not so much so as to prevent the sun from shedding forth its warm and genial rays. The church bells rang their gladdening peals; and in every avenue might be seen the fairy feet of women, tripping it happily along, to offer up thanks at the shrine of Him, the giver of all pleasures, and the fountain of all good. Nothing occurred to disturb the repose in which all seemed to rest. San Francisco is rapidly becoming what she should be—a city noted for its order, peace and quiet.

The "New World," Capt. Averell, arrived at her wharf last Saturday evening, at twenty-five minutes past eight o'clock, making one of the quickest trips on record, from Sacramento. The "New World" is a splendid steamer.

An election for twenty-six delegates to the State Convention, to be held in February next, is to be had on the 17th inst., by order of the Democratic County Convention; so there is a good chance for another row.

A magnificent cane has been presented to Mr. Hall, of the Oriental Hotel, by the ladies of that delightful residence. There is no man more popular than the above gentleman, and whoever gets his good wishes in their net may be sure they have made a good haul.

The steamer "Sea Bird" arrived last night, about 12 o'clock, from San Diego, bringing 52

about 12 o'clock, from San Diego, bringing 62 passengers, and one weeks later news. Among her passengers are the Hon. S. C. Foster, of the Senate, and Mr. Covarrubias, of the Assembly. On account of stress of weather, the Sea Bird was unable to land her cargo, on her downward trip, and was therefore detained much longer on her return.

The following I take from the Alta :

The dates from San Diego are to the 31st ult. From Los Angeles the dates are to the 1st inst.

Gen. Bean arrived at Chino from San Gorgonio, on Friday last, bringing in eleven prisoners, (Indians,) among them Antonio, the son of Antonio Garra, and the leader of the Indians at the time of the attack on Warner's rancho; also Edward Hines, the murderer of Domingo Carriago, and for whose arrest the Governor has offered a reward of \$1000.

A court martial was organized at Chino, to try the Indians, upon charges of treason, murder and robbery. Two Indians, Antonio and Jose Luis, were convicted of the several charges, and sentenced to be shot, which sentence was carried into execution on Sunday last. An Indian boy, also found guilty, was on account of his youth, more mildly dealt with. He was whipped, twenty-five lashes. The remaining Indians were proven to be absent from Agua Caliente at the time the murders were committed, and were therefore released from custody.

These Indians had belonged to Antonio Garra's tribe, and had come to San Gorgonio at the request of that chief, placing themselves in the hands of Juan Antonio, who immediately gave them over to Gen. Bean.

Gen. Bean was to have left Chino for San Diego on Tuesday last, taking with him Antonio Garra, to be confronted with Estudillo and Joaquin Ortega, who are charged by this Indian with having incited the insurrection.

A large number of the State prisoners at work on Angel Island, quarrying, made prisoners of their guard, put them in custody, took possession of the arms and ammunition and escaped. They have not as yet been retaken.
