We make the following extracts from the Stockton Journal of the 9th:

Mr. Street, from Sonora, came down on Tuesday, with some lumps picked up near Sonora since the rains. One weighed \$1100, another \$900, and one of pure gold worth between \$80 and \$90.

FROM SAN DIEGO. - We received, per Golden Gate, a copy of the San Diego Herald of the 5th inst., from which we extract the annexed paragraphs:

A DUEL .- A dispute having arisen between Capt Haig and his Lieutenant, they agreed to settle it by a duel with Colt's large sized revolvers-distance 20 yards After an exchange of two shots, the seconds interfered. and the affair was arranged to the satisfaction of the principals. It is said that the Captain's second shot came near pu ting a quietus to the Lieu enaut's aspiraations for "glory"-the ball having grazed his whiskers.

AN UNFORTUNATE ENCOUNTER occurred yesterday, on the Plaza, at O d Town, between Lt. Watkins, of the "San Francisco Rangers," and one of our citizens, Mr. Pailip Crosthwaite, in which both were wounded-the latter, it is said mortally. We have not been able to learn the origin of the difficulty, but are informed that Mr. Crosthwaite fired first-his ball taking effect in the right thigh of Watkins, who returned the fire, shooting the former through the abdomen.

A DUEL-ALMOST .- We learn that one of our city fathers sent a challenge to another distinguished citizen, a Californian, last week, which was accepted. The challenged party elected to fight on horseback, with California

Forgery.—A person named Benjamin Hayes made a complaint before the Recorder yesterday, that some person, unknown to him, had abstracted his bank book, and forging his name, had drawn \$600, which he had deposited in the savings bank of Messrs. Robinson & Co. The signature to the check appeared to correspond exactly with the one kept in their register, and what tended to quiet any suspicion at all, was the fact of the person presenting the regular bank book of the complainant. We are informed that only two thirds of the amount stated was drawn, the balance still remaining to his credit. A warrant was issued for the apprehension of the forger but so far he has not been arcested.
