**Paper Manufacture.**

It is strange that there should be such a sluggish response to the necessity of paper manufacture in this State. Not only is there an immense demand for the material already existing in California, but the prices which are paid are such as would yield a more certain and tremendous return for an investment of capital than any other business that can be engaged in. At the East it is an excellent business, being among the most prominent ones that require immediate cash payments for products. At the present time such is the scarcity of material that the press is put to all sorts of inconveniences on account of quality and size of paper, sometimes obliged to purchase a very inferior article, or to get that which is nearly double the size needed. Of all articles of consumption it is one which is most inconveniently furnished by importation exclusively, and the capitalist who first engages in the business of supplying our market will realize a revenue that will abundantly requite him for his enterprise.

CHURCH AND STATE.—We learn from undoubted authority that, in the Methodist Church yesterday, the officiating clergyman preached what might be termed a politico-religious sermon, and in the course of his remarks stated, as his opinion, that the "Fugitive Slave Law" was a measure conceived in sin and passed in iniquity, or words to that effect.
