FROM THE INTERIOR.

Yuba.

The *Herald* of Tuesday, through Adams & Co. is received. That journal contains the proceedings of the Butte County Whig Convention, held at Bidwell's Bar, on the 15th July. The nominations will be found in another part of to-day's paper. The following resolutions were adopted by the Convention :

Resolved, That this Convention have heard, with feelings of pride, of the nomination of Mr. Waldo for Governor, and that the nominees of the recent Whig State Convention shall receive our warm and undivided support.

Resolved, That it is the sense of this Convention and of the Whig party of Butte county, that the expenses of the State government should not exceed the revenues of the State.

And, further, that the nominees of this Convention for the Senate and House of Delegates are hereby instructed, if elected, to advocate and use all honorable exertions to reduce the expenditures within the revenues.

MAN SHOT—IMPORTANT ARREST.—Mr. E. Canavan, deputy Sheriff of San Joaquin county, having received information that two of the men engaged in the late robbery of Adams & Co.'s Express at Mormon Island, were in the neighborhood of Douglass and Raney's, on the Calaveras, left yesterday morning to arrest them. Discovering them, he demanded them as prisoners. One of them, named Dawson, endeavored to escape and attempted to draw a pistol on the officer. Canavan immediately fired at, and it is thought, fatally wounded Dawson. The other man he brought to Stockton. Several hundred persons witnessed the proceeding, and

...persons witnessed the proceeding, and all agree in saying that Canavan was quite justifiable.—*Republican*.

Sonoma.

The *Bulletin* of the 16th is received.

Sierra.

Through Adams & Co.'s Express we have received the Downieville *Echo* of the 16th. That paper is decidedly down on the amendments to the license law made by the last Legislature.

A man named Wm. Dicksey, of Boston, was killed on the 14th by a stone falling upon him while working in a drift. He leaves a wife and children at the east. There is a school being taught in the Methodist Church at Downieville. The mining news is favorable.

Sonora.

The *Herald* of Saturday found its way to our sanctum last evening. It has been robbed by its cotemporary the Calaveras *Chronicle*, or some other out of the way neighbor, since leaving home, as it reaches us dry, very dry.

The following items, however, have not appeared heretofore in our columns.

LATER FROM THE SIERRA.—Sheriff Swope returned last evening from pursuit of the Indians, and informs us that the party being too numerous for the scant supply of provisions, one-half set out on their return with him, while the balance remained to hunt the savages still further. Up to the time he left they

ges still further. Up to the time he left, they had tracked the Indians about 75 miles, up to a rancheria, where they had evidently been located temporarily for some time. They had left, however, the day before the party reached. The men left behind are very short of provisions, and, it is feared, will not be able to stay out more than a day or two longer.

ACCIDENTAL DEATH.—Last Saturday, about 12 o'clock, as a party of men were at work on the Gold Mining Company's claim, Brown's Flat, the bank caved in, killing a hired man, a German, who had recently come to work there. He was previously warned that the bank was falling, but persisted in remaining at work.
