MINING.—We glean the following from the Sierra Citizen :

Deep snow and stormy weather had prevented communication with Sears'.

At Eureka Flat, Craig's, Morrison's Ravine, &c., very little is doing, for the want of water.

At Durgan's Flat, a company of Frenchmen are making large wages on claims formerly considered of little value. Formerly the river was flumed opposite these claims, but the lead which runs parallel with the stream was not

The work in the tunnels in the neighborhood is prosecuted, but no big strikes are mentioned. A yield of \$10 or \$15 a day is not considered " worth putting in the papers."

At Goodyear's Bar the majority of miners are unable to work their claims, but all that are in operation are making good wages-from \$6 to \$16 per day to the hand. The tunnel which is now being run into the upper flat, it is confidently expected will reveal a new lead, and open a new field for the enterprise of its projectors.

At Cox's Bar drifting is prosecuted with accustomed vigor and unusual success-indeed, it would seem that the deposits at this place were destined never to fail.

A MAN OF PEACE.-A. B., a correspondent of the Shasta Courier addresses to that paper, in Quaker language, (thee and thou) a letter from Red Bluffs, in which he says : "Another matter worthy of being chronicled was recently achieved by our townsmen, in the pursuit, attack and complete destruction of a band of Indians, who have stolen more property than the entire Digger race is worth." Some fifteen or twenty Diggers were killed in this expedition. A. B. is truly a model Quaker.

COMMOTION.-Considerable commotion was manifested at Red Bluffs recently, as appears by the Shasta Courier, on account of the proceedings of the county officers. A desire to defraud seems to have been imputed to the merchants by the District Attorney, in their neglect to renew their licenses promptly.

MAIL STEAMER .- The arrival of the California at the Bay yesterday, will give us the mail here to-day. The little news she brought, with the list of passengers, the Union gives this morning by telegraph. She brought no later news from New York.

A NEW PAPER.—The first number of the Alameda *Express* was published at Oakland on Saturday. Bonnard & Co. are the publishers, and J. R. Dunglison, editor.

COWHIDING.—The San Francisco Commercial Advertiser says that a man walked into a dance house on Pacific street, on Sunday, commenced abusing one of the women and ended off by cowhiding her.

GOOD ADVICE.—The Shasta Courier calls the attention of the public to the foul condition of the stove pipes in that place, and says that within the last two weeks they have ob erved several on fire late at night. A high wind at the time might, and most probably woald, have again rendered their population houseless, and many of them destitute.

NEW POST OFFICE.-J. C. Spencer, Esq., has been appointed to take charge of a new Post Office established at Horsetown, Shasta county.
