JUSTICE'S COURT .- An interesting case came up before Justice Eaton on Tuesday last, wherein Alex. Bell appeared as pltff. and Henry Dalton as deft. Plaintiff filed a demand for the recovery of one dollar, which had been paid to the agent of deft. for a certain certificate for one share in the Great Real f Estate Distribution, said Distribution having been withdrawn. Defendant put in a written denial of indebtedness to plaintifl, several witnesses were sworn in behalf of both parties and the case submit- d ted. The most important question to be considered was, whether the certificate was an evidence of indebtedness or not .--- Justice Eaton decided that the plaintiff is entitled to recover for the amount of said certificate, it being considered an acknowledged obligation to the holder by the maker. It was therefore adjudged that the defendant pay the sum of one dollar and cost of suit.

GEORGE HALLER vs. H. DALTON.—The subject matter of dispute being the same as the above reported, it was thought advisable by the attorney of defendant, to take a change of venue, a motion to that effect was readily granted, upon the payment of costs and the case sent before Justice Campbell

POLITICAL.—The Democratic County Convention was called for the 12th instead of the 16th inst., the time designated by the State Central Committee, in order that the Delegates might be able to leave the next steamer for San Francisco. As some persons, identified with the party, have insinuated that the premature call of the Convention was made by certain designing men, to carry out a particular policy, we are requested to state, that nothing of the kind was intended by the chairman of the County Central Committee, when he requested the call to be published.

THE INDIAN RESERVATION.—Accounts from the north state that the Reservation in Colusi county is in a flourishing condition. About 2000 Indians are already collected there, who are well pleased with their situation. 1500 acres are under cultivation, and it is estimated there will be sufficient to feed 5000 people for a year. Mr. S. P. Storms is the Sub-Indian Agent and is peculiarly fitted for the position he occupies.
